#### **GENERAL NOTICE**

### Dear Members,

We are pleased to share following new feature (Changes/Amendments) which have been deployed by the PSW Team as per the feedbacks received from Karachi Customs Agents Association:

### 1. Marine Mercantile Department:

- Upon the submission of Single Declaration-Exports (with a declaration of MMD regulated HS Codes), PSW system calculates and reflects the MMD Certificate Fee.
- After successful fee submission, the request is forwarded to the MMD officer through the PSW system.
- The MMD officer has the provision to approve or reject the certificate request in the PSW system.
- The MMD officer also has the provision to call the document from the trader.
- When MMD Officer/Surveyor calls documents, the trader will receive a notification.
- After the trader uploads the documents, MMD officer/Surveyor can view the uploaded documents under the 'Documents' section.

### 2. Drug Regulatory Authority of Pakistan:

#### Drugs Sale License / Drugs Manufacturing License:

- Traders are now able to request DRAP License Registration through the PSW system.
- Traders can request for the following license types:
  - Drugs Sale License.
  - o Drugs Manufacturing License.
- License Registration option is available under Registration Menu.
- Traders will provide the required information; upload supporting documents and submit the request in the PSW system.

#### **Drug Registration:**

- Traders are now able to register DRUGS with DRAP through the PSW system.
- Drug Registration option is available under the Registration menu.
- Traders will provide the required information; upload supporting documents and submit the request in the PSW system.

# 3. Unified Registration System - Department of Plant Protection:

#### **Premises Renewal Process**

- Traders can request the Premises Renewal using the PSW system.
- After submission of request, trader will pay the prescribed fee for premises renewal using the Alternative Delivery Channels.
- The officer has the provision to approve/reject or call the document against the premises renewal request.

#### **Premises Amendment Process:**

- Traders can request amendment in premises information using PSW system.
- After submission of request, traders pay the prescribed fee for amendment in premises information using the Alternative Delivery Channels.
- After successful payment, the request is assigned to the officer.
- The officer has the provision to approve/reject or call the documents against the premises amendment request.

### 4. Single Declaration Imports and Exports Enhancements:

- While filling Single Declaration-Imports, under commodity information section; trader will be able to select the Publication Price against the commodity.
- Traders can declare an item as not a sim device and not requiring a PTA certificate.
- In the duty and taxes interface, the statutory rate and applicable rate are now being displayed in percentage.
- In the Single Declaration Export View, users can view the selected Shipping Line/Airline name.
- GD Number and BL number fields are included in the Release Order grid under the LPCO menu for better visibility and search of transaction.

## 5. Sindh Infrastructure Development CESS Exemption/Waiver against the NTN/FTN:

- Traders have the option to initiate and submit requests for Sindh Infrastructure Development CESS Exemption/Waiver against their NTN/FTN through the PSW system.
- Officers from the Sindh ET&NC Department can access and view the CESS exemption/waiver request by using the PSW system.
- Once accessed, the Sindh ET&NC Department's officer can set the validity date and proceed to approve the CESS exemption/waiver request.
- The officer also has the provision to decline the request if necessary.
- Upon approval of CESS Exemption/Waiver request by the ET&NC officer, the system ensures that CESS will not be generated against declarations having the exempted NTN/FTN until the specified validity date.

# 6. Single Declaration Export

#### Live

- Export SD cannot be saved or processed until a Financial Instrument is attached. To amend more than one container number in Export SD the user has to go back and forth from 1" screen to last screen to change each container number.
- Bank name change shall be allowed in amendment.
- No option is available to save more than five containers at once in Export SD.
- Export SD cannot be saved or processed until Financial Instrument is attached.
- If for some reason export SD is submitted but goods cannot be passed in at the terminal, the Shipping Line name is not showing in view option after submission of Export SD.

# 7. Single Declaration Import

- The load port should be same as per BL in SD. Currently it is showing 2nd last port of call of the Vessel. (Its implementation is correct.)
- The option to copy/clone import SD is not available in PSW System.
- While checking duty and taxes the calculation should show percentage instead of decimals in PSW.

#### 8. LPCO

Live

• Under LPCO tab, the option should be available to search by BL. No. for Release Orders (RO) or the column for BL. No. must be visible.

#### 9. Payment

Live

- Agent name is not shown with the name of Trader name at additional payment PSID page.
- WeBOC token, Single Declaration Fee and Fumigation fee (if any) cannot be refunded back. (Fee is nonrefundable.)
- User shall be able to view the paid bills and generate payment receipt.

#### 10. Changes in WeBOC

In Development:

• After the completion of GD by customs officer the Status of GD shows "Hold by RO/PSW" for every GD. The caption of the status should be "In Processing" for all GD's and for GD's that require RO from OGA may show that caption i.e. "Hold by RO/PSW".
